Sub: Disclosure under Regulation 51(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Part B of Schedule III thereto.

This is to inform that CRISIL Ratings Limited (CRISIL) has re-affirmed the credit ratings assigned to the following instruments:

1. CRISIL AA-/Negative assigned to Bank loan facilities to Rs. 12,700 crores (reduced from Rs. 15000 crores), Retail Bonds to Rs. 500 crores (reduced from Rs. 2000 crores), Non-convertible Debentures of Rs. 1500 crores, Non-convertible Debentures of Rs. 2000 crores, Non-convertible Debentures aggregating to Rs. 1582.38 crores (reduced from Rs. 1777.51 crores) and Subordinated Debt aggregating to Rs. 180 crores (reduced from Rs. 400 crores);
2. CRISIL PP-MLD AA-r/Negative assigned to Long-term Principal Protected Market Linked Debentures of Rs. 300 crores and Long-term Principal Protected Market Linked Debentures to Rs. 60.61 crores (reduced from Rs. 460.61 crores); and
3. CRISIL A1+ assigned to Commercial papers of Rs. 1000 crores and Commercial paper programme (IPO Financing) of Rs. 2500 crores.

CRISIL has also withdrawn its ratings on the bank loan facilities of Rs 2300 crore, long-term principal-protected market-linked debentures (PPMLD) of Rs. 400 crores, subordinated debt of Rs 220 crore, retail bonds of Rs 3500 crore and non-convertible debentures(NCDs) of Rs 195.13 crore in line with its withdrawal policy.
