Workers at the University of Hong Kong (HKU) removed the Tiananmen Massacre statue, widely known as the Pillar of Shame, on Wednesday, months after the university had said the statue must go.

This monument was created by a Danish artist in memory of those killed in the Tiananmen Square crackdown in Beijing in 1989. "The Council of the University of

Hong Kong (HKU Council) made a decision at its meeting on December 22 (Wednesday) to remove a statue, widely known as the Pillar of Shame, from campus. The decision on the aged statue was based on external legal advice and risk assessment for the best interest of the University," the university said in a statement.

None of the parties has ever received permission from the university to display the statue on its campus. In this regard, the university has the right to take appropriate action at any time, according to the press release.

The university said that the deci-

sion had been made due to the potential safety issues resulting from the fragile statue and potential legal risks for the organization.

"Latest legal advice given to the University cautioned that the continued display of the statue would pose legal risks to the University based on the Crimes Ordinance enacted under the Hong Kong colonial government," the

statement said. Earlier this year, the university requested that the statue be removed for safekeeping. The educational organization will continue to receive legal advice on further actions with regard to the monument. Sophie Richardson. Human Rights Watch's China Director. said slammed the Chinese government for being afraid of a statute.



Last week, Moscow submitted draft security documents demanding that


NATO deny membership to Ukraine and other former Soviet countries and roll back the alliance's military deployments in Central and Eastern Eu rope

Moscow presented its demand amid soaring tensions over a Russian troop buildup near Ukraine that has stoked fears of a possible invasion.

US President Joe Biden warned Putin in a conference call earlier this month that Russia will face "severe consequences" if it attacks Ukraine.

The British government said Thursday it won't introduce any new coronavirus restrictions until after Christmas, and called early studies on the severity of the omicron variant encouraging. Health Secretary Sajid Javid said two studies suggesting omicron carries a significantly lower risk of hospitalisation than the previously dominant delta strain was "encouraging news." But he said it was "not very clear yet...by how much that risk is reduced." The UK Health Security

Agency is due to publish new data on omicron later Thursday.

It follows two studies, from Imperial College London and Scottish researchers. that found patients with omicron were between 20% and 68% less likely to require hospital treatment than those with delta
